### **Reports, Director, and Staff Comments:**

**Fire Chief Report/Announcements:** Chief Miller reiterated the need for the board to complete the required Sexual Harassment and Ethics trainings which are available on the CSDA website. Chief Miller will resend the login information to each of the board members.

Chief Downs was out on a strike team at Happy Camp for 14 days and Chief Miller was recently assigned as a heavy equipment boss at Smith River for 10 days; both of which will provide revenue for the district.

Engine 316's maintenance of replacing the motor and pump should be completed and returned to the station soon.

Chief Downs reported that the local strike team that accompanied him to Happy Camp were the shining stars of the strike team division, setting examples of hard work and perseverance. They completed almost 3 miles of hose lay on some of the steepest terrain in the state within one night.

Chief Downs stated that there was a small vegetation fire by the transfer station in Wilseyville over the weekend. The West Point crew was first on scene and quickly knocked it down. The cause of the fire has been deemed suspicious.
